Achievements in PrEP programs (2022-2023)





CAB LA PrEP in Ukraine

- Advocacy of the LA PrEP in Ukraine, 2022-May, 2023 (#SoS 2.0)
- Launch of the pilot project on CAB LA PrEP in Kyiv and Lviv for 100 MCM - PEPFAR (Aug, 2023 – Dec, 2025), 100 courses (CDC, UPHC, APH)
- Implementation of national (Ukraine) and regional (EECA) information campaign (#SoS 2.0)



PrEP pilot project in Balkans

 3 countries in the Balkans have launched PrEP project: North Macedonia - 64 Bosnia and Herzegovina -17 Montenegro - start on 9th of Oct 2023

PrEP insights:

- PrEP coverage from 95K in 2020 to 200k in 2023 to 500K in 2025
- Implementation of communitybased service delivery model
- Widely attention is expanding to other key groups (PWUD, SW)



Analysis of protocols for PrEP

- Analysis is held in 7
 countries
 (Armenia, Kazakhstan,
 Kyrgyzstan, Georgia,
 Tajikistan, Ukraine,
 Uzbekistan)
- Based on the analysis recommendations for clinical protocols were developed in order to include PrEP as a standard service package and adjust current protocols according to the WHO recommendations

PrEP in Balkans: North Macedonia







PrEP

2021: PrEP pilot as an implementation study

- Officializing the national PrEP guidelines
- Procurement of PrEP drug using #SoS 2.0 funds
- One new HIV+

2022: Continued per pilot protocol

 No new recruitment due to ARV procurement crisis

2023: Pilot started as Program

- Joint funding
- Recruitment again
- New PrEP donation through #SoS 2.0
- Expansion to other KP



FUTURE steps

- Consolidate program
- New objectives 150 people
- Plans for intensified promotion
- Advocacy increase funding through National HIV Program for 2024



LESSONS learned

- National PrEP guidelines beneficial, but not a prerequisite
- Necessary support from WHO instrumental
- Strong advocacy work on price reduction

PrEP provides an opportunity for:

insight into the trends of the epidemic among most-at-risk populations increasing awareness of HIV and HIV testing and other services contributes to preventing new infections – even if numbers are low

PrEP in Balkans: Bosnia and Herzegovina & Montenegro





Pilots implementation

- Procurement of PrEP drug using #SoS 2.0 funds in 10 times cheaper
- Clinical Pilot Protocol was developed
- Clinical Protocol was developed in BiH
- Training was conducted with support of WHO expert
- A study visit was conducted
- Flexible service delivery schedule
- Methodological guidelines are developed (BiH)



Lessons learned

- Review of procurement models of PrEP
- Change regulators rules and perception regarding generics needed



Next steps

- Development of National Protocol
- Funding of PrEP-related expenses included into national funding schemes in both countries





#SoS 2.0: PrEP in the EECA region







In 2022, ECOM held Analysis of National PrEP Protocols in 7 countries (Armenia, Georgia, Kazakhstan, Kyrgyzstan, Uzbekistan, Tajikistan and Ukraine) and provided recommendations to align the national protocols with the WHO guidelines. In 2023

PrEP coverage is low and do not meet the WHO goals

Challenges and barriers to solve:

- lack of PrEP programs in some countries
- lack of National Protocols in some countries
- Limited access to PrEP some KPs

Current & future steps:

- Equal access for all KPs
- Programs expansion
- Introduction and implementation of innovations
- Advocacy of generic
- Sustainability of programs
- Digitization promoting the development of PREP services


- CAB LA in Ukraine

PrEP eligibility fo KPs (ECDC Data)



In 2022, 35 countries provided data on which key populations were eligible for PrEP (Figure 3). Gay men and other men who have sex with men were most frequently reported as eligible for PrEP: 30 of 35 countries reported that they are eligible for PrEP. Prisoners were least frequently reported as eligible for PrEP, with only four of 35 countries reporting them eligible.

Figure 3. Populations deemed eligible for PrEP across Europe and Central Asia (n=35)






Developing IT solutions to enhance service delivery, data collection, analysis and presentation of results



- 1. National info system for collecting, storing, analyzing, reporting and presenting data on all HIV related areas, incl. PrEP
- 2. Virtual / online / electronic social worker as a source of reliable up-to-date comprehensive information on all HIV related areas, incl. PrEP for clients and social / outreach workers, peers and other relevant parties
- 3. Regional HIV data dashboard to allow for presentation, analysis and comparison on national, cross-country and regional HIV related data, including implementation of and coverage by PrEP programs



The DHIS2 based National info system will consist of:

- database (data entry possible via mobile app or desktop version)
- service provider mobile app for data entry
- service provider desktop access for entering, storing, working with data
- ✓ dashboards

And will be accompanied by the client mobile app



Al based e-Social Worker as a virtual assistant for clients and social workers



- A mobile app that will allow to take some load off social workers by providing them with reliable comprehensive info they need to be able to work effectively with clients and by providing clients access to the info, as well as info on contacts and details of services available to them
- Offline version in form of guided conversation – menu options to choose the topic of interest and an online version with Al and virtual human, allowing for an open conversation with voice / text entry of the question at hand
- PrEP block will cover the theory on what it is, why and who needs it, as well as practical aspects on where and how to get it and how to take it, etc., tailored to the country where the client is based (who is implementing the solution)



First countries for piloting – UA, KG

Pilot in Ukraine in 2024 for 50 000 clients (co-funding from Gilead)

The solution can be used by other countries in various formats, based on needs and available resources

PrEP: Human rights, GBV, discrimination



REACT CLM tool for human rights related barriers monitoring and response

Challenges

- Awareness about PrEP availability at community level is low
- Receiving of PrEP within state institutions is complicated
- PrFP associated with MSM
- Limited access of PrEP for migrants
- Clients are afraid to request PrEP due to the risk of disclosure of sexual orientation
